I hereby give my consent and permission to Prestonwood Baptist Church, Inc. Specifically, I hereby allow such photos and videos of myself and/or my family and/or my child(ren) to be published via print, video, or website affiliated with PBC and/or on social media without further notice to me. I also specifically authorize CLC to publish such photos and videos on the CLC website and any CLC social media pages, including Facebook.

Should the Director of my child(ren)'s class choose to publish photos and/or videos on social media or other apps for the benefit of parents and/or guardians, notification of same may be sent to the email address(es) provided on my child(ren)'s application.

Additionally, I understand that publication may be accomplished electronically via the Internet, and that, after publication, PBC will be unable to prevent persons from gaining access to the Internet, copying the photographs and/or videos, and subsequently using, altering, or republishing them without my consent. As such, I also specifically waive any claim for damages against CLC, PBC, and the Prestonwood Parties for the use, alteration, or republication of the photographs and videos by third parties accessing the Internet or obtaining copies of the print or video material.

I understand that CLC staff may take photographs and/or video of my child(ren) from time to time for classroom use.

Given the prevalence of portable electronic devices, I understand and acknowledge that others, including visitors and/or anyone present while I and/or my child(ren) is/are present at PBC, may take photographs and/or videos of myself and/or my child(ren) with or without my knowledge and with or without the knowledge of the Prestonwood Parties, and may publish such media without my consent. I acknowledge that such actions are outside of the reasonable control of the Prestonwood Parties, and I waive any claims for damages against CLC, PBC, and the Prestonwood Parties for the use, alteration, or publication of such photographs and/or videos by others, including invitees of the Prestonwood Parties.

I HEREBY AGREE TO FOREVER RELEASE, DISCHARGE, INDEMNIFY, HOLD HARMLESS, AND DEFEND THE PRESTONWOOD PARTIES FROM ANY INJURIES, DAMAGES, CLAIMS, DEMANDS, ACTIONS, OR CAUSES OF ACTION WHATSOEVER THAT MAY ARISE OUT OF OR HAVE A CONNECTION WITH ANY PHOTOGRAPHING, VIDEOTAPING, OR FUTURE PUBLICATION OF MYSELF OR MY CHILD(REN)'S LIKENESS IN THE CONTEXT OF A CLC-RELATED EVENT, WHETHER FROM ACTS OF ACTIVE OR PASSIVE NEGLIGENCE ON THE PART OF THE PRESTONWOOD PARTIES.
